Medical College, Swangi, Wardha for purpose of recognition of MD(DVL) against increased intake from 01(One) to 02(Two) seat(s) granted by Datta Meghe Institute of Medical Sciences (Deemed University), Wardha was considered by the Board of Governors and it was decided as under:-

The Board of Governors considered the assessment report (May, 2012) and noted that MD(DVL) is already recognized with 01(One) seat(s) and decided to recommend that MD(DVL) against increased intake from 01(One) to 02(Two) seat(s) granted by Datta Meghe Institute of Medical Sciences (Deemed University), Wardha in respect of students being trained at J.
