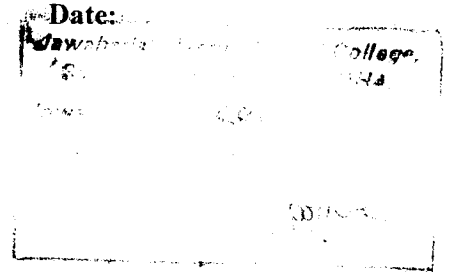

*The Board of Governors considered the assessment report (May, 2012) and noted that MD(Pathology) is already recognized with 03(Three) seat(s) and decided to recommend that MD(Pathology) against increased intake from 03(Three) to 06(Six) seat(s) granted by Datta Meghe Institute of Medical Sciences (Deemed University), Wardha in respect of students being trained at J. - 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall inevitably result in stoppage of admissions to the concerned Post Graduate Course.
