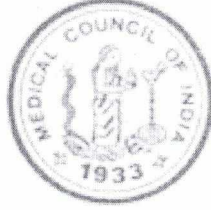

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 30/03/2016 considered the Council Assessor's Report (August, 2015) on the physical and other teaching facilities available at Jawaharlal Nehru Medical College, Sawangi (Meghe), Wardha for the award of M.Ch(Cardio Thoracic Surgery) qualification for 1 seat under Datta Meghe Instt. of Medical Sciences (Deemed University), Nagpur. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (August, 2015) and decided to recommend to the Central Government that M.Ch(Cardio Thoracic Surgery) qualification for 1 seat granted by Datta Meghe Instt. of Medical Sciences (Deemed University), Nagpur in respect of students being trained at Jawaharlal Nehru Medical College, Sawangi (Meghe), Wardha be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
