



Sir,

I am to state that the General Body of this council at its meeting held on 11.03.2010 considered the compliance together with Council inspector report (May 2009) on the standard of examination and other teaching facilities available at J.N. Medical College, Swangi Wardha for purpose of recognition of M.D.(Paediatrics) qualification granted by Datta Meghe Institute of Medical Sciences University, Nagpur.

The Council approved the following recommendations of the Postgraduate Committee:-

"The Postgraduate Committee considered the compliance together with Council inspector report (May 2009) and noted that Dr. P.P. Sanghvi, Associate Professor, Unit-III, does not possess prescribed academic qualification.

However, the teaching faculty complement other than the teacher mentioned above is adequate and complete; and hence decided to recommend that M.D.(Paediatrics) qualification granted by Datta Meghe Institute of Medical Sciences University, Nagpur in respect of students being trained at J.N. Medical College, Swangi Wardha be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 2(Two) students per year."

The Postgraduate Committee further decided that the attention of the institute be drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.




